WHEREAS, Open Competitive Bidding for the Re-Bidding of Drugs and Medicines 2021 charged to Trust Fund was conducted in accordance with the Republic Act 9184 and its Revised Implementing Rules and Regulations;

WHEREAS, the Invitation to Bid (IB) was posted in PhilGEPS dated April 30, 2021 and in conspicuous place at the premises of MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL compound;

### CONTRACT AGREEMENT

- (f) the Entity's Notification of Award.


