WHEREAS, Open Competitive Bidding for the Procurement of Supply, Delivery, Installation and Commissioning of Medical Waste using Treatment Technology endorsed in DOH Health Care Waste Management Manual was conducted in accordance with the Republic Act 9184 and its Revised Implementing Rules and Regulations;

WHEREAS, the Invitation to Bid (IB) was posted in PhilGEPS dated May 20, 2021 and in conspicuous place at the premises of MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL compound;

WHEREAS, a Pre-Bid Conference was held on May 28, 2021, 10AM at the Procurement Conference Room, Mariveles Mental Wellness and General Hospital – Mariveles, Bataan with five (5) prospective bidders attending namely;

3. A.M.I. Equipment Services and Solutions

5. MHR Health Care, Inc.

WHEREAS, four (4) prospective bidders procured the bidding documents, namely;

WHEREAS, on the schedule Submission and Opening of Bids last June 09, 2021, 1PM at the IHOMP Lobby, Mariveles Mental Wellness and General Hospital – Mariveles Bataan, four (4) bidders tendered their Bids, namely;

WHEREAS, on June 24, 2021, the BAC denied the request for Reconsideration of Jozeth Trading;



THIS AGREEMENT made the ____ day of June 2021, between **MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL – P. Monroe St., Poblacion, Mariveles Bataan** (hereinafter called “the Entity”) **ONE TOP MEDICAL SYSTEMS RESOURCES – #7 Calderon St., Brgy. Marilag, Project 4, Quezon City** (hereinafter called “the Supplier”).

WHEREAS, the Entity invited Bidders for certain goods and ancillary services, viz., **PROCUREMENT OF SUPPLY, DELIVERY, INSTALLATION, AND COMMISSIONING OF MEDICAL WASTES USING TREATMENT TECHNOLOGY ENDORSED IN DOH HEALTH CARE WASTE MANAGEMENT MANUAL**, had accepted a Bid by the Supplier for the supply of those services in the sum of **TWENTY-ONE MILLION PESOS only (Php 21,000,000.00) PHILIPPINE CURRENCY**, (hereinafter called “the Contract Price”).

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services therein in conformity in all respects with the provisions of the Contract as follows:

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
