WHEREAS, Open Competitive Bidding for the Procurement of Drugs and Medicines 2019 for Second Semester was conducted in accordance with the Republic Act 9184 and its Revised Implementing Rules and Regulations;

WHEREAS, the Invitation to Bid (IB) was posted in PhilGEPS dated May 07, 2019 and in conspicuous place at the premises of MARIVELES MENTAL HOSPITAL compound;

WHEREAS, A Pre-Bid Conference was held on May 15, 2019, 10AM at the Procurement Conference Room, Mariveles Mental Hospital – Mariveles, Bataan with (6) prospective bidders attending, namely:

- 3) RBC-MDC Corporation
- 4) Wisenheimer Trading
- 5) SGS Health Care Co.
- 6) Steritex Medical System

WHEREAS, five (5) prospective bidders procured the bidding documents and submitted their respective bid proposals namely:

- 1) Zuellig Pharma Corporation
- 2) RBC-MDC Corporation
- 3) Metro Drug Inc
- 4) Quad-Gen Pharmaceuticals
- 5) Eurocare Pharma Inc.

WHEREAS, the Submission and Opening of Bids took place on May 27, 2019, 10AM at the Procurement Conference Room, Mariveles Mental Hospital – Mariveles, Bataan;

WHEREAS, the original envelopes, containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents were checked and verified by the BAC in the presence of the bidders. The results are as follows:


