Approving the Award of Contracts for the Repair/ Renovation of Existing Portion of Concrete Fence

WHEREAS, Open Competitive Bidding for the Repair/ Renovation of Existing Portion of Concrete Fence was conducted in accordance with the Republic Act 9184 and its Revised Implementing Rules and Regulations;

WHEREAS, the Invitation to Bid (IB) was posted in PhilGEPS dated August 13, 2019 and in conspicuous place at the premises of the MARIVELES MENTAL HOSPITAL compound;

WHEREAS, A Pre-Bid Conference was held on August 23, 2019, 2:00PM at the Procurement Conference Room, Mariveles Mental Hospital – Mariveles, Bataan with two (2) prospective bidders attending, namely;

1. OMAR K.D. General Construction and Trading
2. Carsen Builders and Trading

WHEREAS, three (3) prospective bidder procured the bidding documents and submitted their respective bid proposal, namely;

1. OMAR K.D. General Construction and Trading
2. Carsen Builder and Trading
3. De Jesus Construction

WHEREAS, the Submission and Opening of Bid took place on September 04, 2019, 10:00 AM at the Procurement Conference Room, Mariveles Mental Hospital – Mariveles, Bataan;

WHEREAS, the original envelope, containing the Eligibility and Technical Documents was opened. The presence, completeness and correctness of the required documents were checked and verified by the BAC in the presence of the bidders. The results are as follows:

1. OMAR K.D. General Construction and Trading - eligible
2. Carsen Builder and Trading – ineligible
3. De Jesus Construction – eligible

WHEREAS, Carsen Builders and Trading failed to attach the copy of Professional Tax Receipt (PTR) of the Project Manager and Civil Engineer, as part of the eligibility and technical requirements. Thus, it was found to be ineligible. Consequently, financial document was not opened and the Copy 1 and Copy 2 of Eligibility and Technical Envelope and Financial Envelope were returned to Carsen Builders and Trading;

WHEREAS, the Financial Proposal of the eligible bidders was opened. The presence, completeness and correctness of the entire document were checked and verified by the BAC. Upon checking, the Bidder was declared "Eligible" and rated "PASSED" and subsequently their respective bid was publicly read and posted in the Abstract of Bids, to wit:

WHEREAS, the detailed evaluation of bids conducted on September 05, 2019 resulted in the following as calculated;

WHEREAS, on September 09 – 11, 2019, the BAC together with the Technical Working Group (TWG) conducted the post-qualification evaluation of OMAR K.D. General Construction and Trading and reported on September 11, 2019, that all statements made and documents submitted were validated except for the Professional Tax Receipt (PTR) of Material Engineer which were found different from the PTR verified from the original copy;

WHEREAS, on September 11, 2019, the BAC notified OMAR K.D. General Construction and Trading of its post-disqualification;





CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This **AGREEMENT**, made this 20th day of September 2019 between **Mariveles Mental Hospital**, Mariveles, Bataan hereinafter called the Procuring Entity and **OMAR K.D. General Construction and Trading**, Balanga City hereinafter called the Contractor.

WHEREAS, the Procuring Entity is desirous that the Contractor execute the project **REPAIR/RENOVATION OF EXISTING PORTION OF CONCRETE FENCE** and hereinafter called the works and the Procuring Entity has accepted the Bid for **ONE MILLION FORTY-THREE THOUSAND FOUR HUNDRED NINETY-SIX PESOS & 68/100 ONLY (Php1,043,496.68)** with duration of **90 calendar days** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form and be read and construed as part of this Agreement, to wit:
 - a. General and Special Conditions of Contracts;
 - b. Drawing/Plans;
 - c. Specifications;
 - d. Invitation to Apply for Eligibility and to Bid;
 - e. Instructions to Bidders;
 - f. Bid Data Sheet;
 - g. Addenda and/or Supplemental/Bid Bulletin, if any;
 - h. Bid Form, including all the documents/statements contained in the Bidders bidding envelopes, as annexes;
 - i. Eligibility Requirements, documents and/or statements;
 - j. Performance Security;
 - k. Credit Line issued by a licensed bank, if any;
 - l. Notice of Award of Contract and the Bidders conforme thereto;
 - m. Other contract documents that may be required by existing laws and/or the Entity;
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the Works and remedy any defects therein in conformity in all respects.


