WHEREAS, the Invitation to Bid (IB) was posted in PhilGEPS dated September 1, 2023 and in conspicuous place at the premises of MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL compound;

WHEREAS, a Pre-Bid Conference was held on September 11, 2023, 9AM at Procurement Conference Room and/or through webcasting via Zoom, Mariveles Mental Wellness and General Hospital – Mariveles, Bataan eight (8) prospective bidders attending namely;

WHEREAS, during the post-qualification checking for Item No. 3 4 unit Automated External Defibrillator and Item No. 4 3 unit Defibrillator with Paddles, VARIANCE TRADING CORPORATION was determined to have the Lowest Calculated Bid (LCB). However, upon careful examination, verification, validation, and ascertainment of all statements and representations made, VARIANCE TRADING CORPORATION failed to comply with the minimum specifications indicated in the Terms of Reference (TOR) particularly the "Shock: IEC 68-2-27" for AED which the bid proposal of the LCB indicates "IEC 68-2-32". For the Defibrillator with paddles the following specifications were not met. "Design Standards: Meets or exceeds applicable requirements of EN 60601-1, EN 60601-2-4, EN 60601-2-27, EN1789" (Bid offer of the LCB did not meet the EN 60601-2-27), "Patient Impedance Range: 15 to 300ohms" (Bid offer indicates 25 to 300ohms only), and "Patient Impedance Range: Pulse Width: 40msec ± 2msec" (Bid offer indicates 20ms only). Hence, the LCB was found non-responsive and does not conformed to the Technical Specification as required in the bidding documents.;

WHEREAS, after the BAC has not notified VARIANCE TRADING CORPORATION in writing of its post-disqualification on October 6, 2023, the BAC initiated the same post-qualification process of the bidder with Second Lowest Calculated Bid (2nd LCB);

WHEREAS, Section 55.1 of the 2016 Revised IRR of R.A. 9184 provides, among others that "Decisions of the BAC at any stage of the procurement process may be questioned by filing a request for reconsideration within the three (3) calendar days upon receipt of written notice or upon verbal notification.;

WHEREAS, the BAC Secretariat did not receive any request for reconsideration from VARIANCE TRADING CORPORATION within the period provided by the law.;

WHEREAS, the LTE BIOMEDICAL SOLUTIONS as the 2nd LCB was found compliant with all the technical, financial, and post-qualification requirements and conditions as specified in the Bidding Documents.;

WHEREAS, during the post-qualification checking for Item No. 6 1 unit Digital X-ray Machine, PATIENT CARE CORPORATION was determined to have the Lowest Calculated Bid (LCB). However, upon careful examination, verification, validation, and ascertainment of all statements and

representations made, PATIENT CARE CORPORATION failed to comply with the minimum specifications indicated in the Terms of Reference (TOR) particularly the "Protection grade equivalent to IPX3 or better according to standard IEC 60529", however, the proposal of the LCB is IPX1 only. Hence, the LCB was found non-responsive and does not conform to the Technical Specification as required in the bidding documents.;

WHEREAS, after the BAC has notified PATIENT CARE CORPORATION in writing of its post-disqualification on October 9, 2023, the BAC initiated the same post-qualification process of the bidder with Second Lowest Calculated Bid (2nd LCB);

WHEREAS, the BAC received a Motion for Reconsideration on October 10, 2023 from PATIENT CARE CORPORATION with documents having modified specification.;

WHEREAS, on October 17, 2023, the BAC and its TWG deliberated the Motion for Reconsideration (MR) wherein the BAC decided to DENY the MR giving emphasis on Section 26.1 of the IRR, x x x, prohibits bidders from modifying their bid, through the submission of new or additional documents after the deadline for submission, receipt and opening of bids, to support its eligibility or qualification as this constitutes an improvement of bids; and is violative of the rule that bids must be submitted complete on the date, time and place for the submission of bids.;

WHEREAS, the BAC and its TWG conducted the post-qualification checking for COSMO MEDICAL INC. as the 2nd LCB, which also failed to comply with the minimum specifications indicated in the Terms of Reference (TOR) particularly the Tilting Range and Tilting Mechanism as the offer of the 2nd LCB doesn't have tilting feature. Hence, the 2nd LCB was found non-responsive and does not conform to the Technical Specification as required in the bidding documents.;

WHEREAS, the BAC has notified COSMO MEDICAL, INC. in writing of its post-disqualification on October 23, 2023;

WHEREAS, the BAC received a Motion for Reconsideration on October 24, 2023 from COSMO MEDICAL, INC. requesting to consider 4 ways or 6 ways table movement for the Tilting Specification. However, the said request was DENIED by the BAC. Hence, the answer to the Motion for Reconsideration indicating the denial was sent on October 27, 2023.;

NOW THEREFORE, on the basis of the above, the herein members of the BAC HEREBY RESOLVE, to award the items listed below to the bidders that were determined as the Lowest Calculated and Responsive Bid (LCRBs) or Single Calculated and Responsive Bid (SCRBs);
