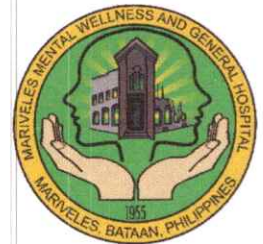

CONTRACT AGREEMENT

THIS AGREEMENT made this JAN 23 2024 day of January 2023, between **MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL** – P. Monroe St., Poblacion, Mariveles Bataan (hereinafter called “the Entity”) **OS1 SOLUTIONS, INC.** – 69 Roosevelt Ave. Parkwood Executive Village Phase 1, Brgy Maybunga, Pasig City (hereinafter called “the Supplier”).

WHEREAS, the Entity invited Bidders for certain goods and ancillary services, viz., **PROCUREMENT OF ENDPPOINT PROTECTION FIREWALL SYSTEM HARDWARE UPGRADE**, had accepted a Bid by the Supplier for the supply of those services in the sum of **TWO MILLION FOUR HUNDRED FIVE THOUSAND NINE HUNDRED NINETY-NINE PESOS only (Php 2,405,999.00) PHILIPPINE CURRENCY**, (hereinafter called “the Contract Price”).

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services therein in conformity in all respects with the provisions of the Contract as follows:

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
