CONTRACT AGREEMENT

THIS AGREEMENT made this day of December 2023, between MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL – P. Monroe St., Poblacion, Mariveles Bataan (hereinafter called "the Entity") TOYOTA BATAAN INC. – Tuyo Balanga City Bataan 2100 (hereinafter called "the Supplier").
