**For the Procurement of Foodstuffs for the 1<sup>st</sup> Semester of 2025 (EPA)**

WHEREAS, Open Competitive Bidding for the Procurement of Foodstuffs for was conducted in accordance with the Republic Act 9184 and its Revised Implementing Rules and Regulations;

WHEREAS, the Invitation to Bid (IB) was posted in PhilGEPS dated October 29, 2024 and in conspicuous place at the premises of MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL compound;

WHEREAS, a Pre-Bid Conference was held on November 6, 2024, 03:00 PM at Procurement Conference Room and/or through webcasting via Zoom, Mariveles Mental Wellness and General Hospital – Mariveles, Bataan two (2) prospective bidders attending namely;

1. RCU Fruits and Vegetables Trading
2. Samcor Consumer Goods Trading

WHEREAS, six (6) bidders procured the bidding documents, namely;

1. RCU Fruits and Vegetables Trading – Fruits
2. Corazon Viray Cruz General Merchandise – Meat
3. Distribution Solutions Phils., Inc.- Milk Supplement
4. GB Distributors Incorporated – Milk Supplement
5. LCJ General Merchandise – Grocery Items
6. Mardai Enterprises – Grocery Items

WHEREAS, on the schedule Submission and Opening of Bids last November 18, 2024, 3:00 PM, at the Mariveles Mental Wellness and General Hospital Compound– Mariveles Bataan, six (6) bidders tendered their Bids, namely;

1. RCU Fruits and Vegetables Trading – Fruits
2. Corazon Viray Cruz General Merchandise – Meat
3. Distribution Solutions Phils., Inc.- Milk Supplement
4. GB Distributors Incorporated – Milk Supplement
5. LCJ General Merchandise – Grocery Items
6. Mardai Enterprises – Grocery Items

WHEREAS, the original envelopes, containing the Eligibility and Technical Documents were opened. The presence, completeness and correctness of the required documents were checked and verified by the BAC in the presence of bidders. The results are as follows;

1. RCU Fruits and Vegetables Trading – eligible
2. Corazon Viray Cruz General Merchandise – eligible
3. Distribution Solutions Phils., Inc.- eligible
4. GB Distributors Incorporated – eligible
5. LCJ General Merchandise – eligible

WHEREAS, during the opening of the Technical Bid Envelope, it has been found that the declared Single Largest Completed Contract (SLCC) of Mardai Enterprises did not meet the percentage set forth in the bidding requirements, therefore, the BAC deemed the submitted technical bidding documents as non-compliant, hence, Financial Bid Envelope shall no longer be opened;

WHEREAS, Section 55.1 of the 2016 Revised IRR of R.A. 9184 provides, among others that "Decisions of the BAC at any stage of the procurement process may be questioned by filing a request for reconsideration within three (3) calendar days upon receipt of written notice or upon verbal notification";

WHEREAS, on the same day, the BAC through its Secretariat, has notified Mardai Enterprises in writing and was given three (3) calendar days to respond and address the noted non-compliance by way of Motion for Reconsideration, hence, the unopened Second Envelope containing the Financial bid was retained by the BAC until the request for reconsideration has been resolved;

WHEREAS, the Financial Proposal of the eligible bidders were opened. The presence, completeness and correctness of the entire documents were checked and verified by the BAC. The result are as follows;

1. RCU Fruits and Vegetables Trading – eligible
2. Corazon Viray Cruz General Merchandise – eligible
3. Distribution Solutions Phils., Inc.- eligible
4. GB Distributors Incorporated – eligible
5. LCJ General Merchandise – eligible

WHEREAS, the bidders who were declared “Eligible” and were rated “PASSED” and subsequently their respective bids were publicly read and posted in the Abstract of Bids, to wit;

WHEREAS, on November 20, 2024, Mardai Enterprises filed a Motion for Reconsideration, however, it was decided by the BAC during the deliberation that the Motion of the said bidder shall not be granted in compliance with the Republic Act 9184 also known as the Government Procurement Reform Act and its IRR, and on November 22, 2024, the BAC through its Secretariat issued a Notice of Post-Disqualification of the said bidder;

WHEREAS, Mardai Enterprises was amenable to not granting the Motion for Reconsideration;

WHEREAS, during post-qualification, it has been found that RCU Fruits and Vegetables Trading and LCJ General Merchandise failed to comply with the Technical requirement, particularly with the SLCC requirement. In addition, LCJ General Merchandise failed to comply with the required submission of Production / Delivery Schedule as specified in the bidding documents, moreover, the said bidder also failed to comply with the Financial requirement particularly with the Net Financial Contracting Capacity (NFCC) due to incorrect computation of the said requirement;

WHEREAS, on November 22, 2024, the BAC through its Secretariat has notified RCU Fruits and Vegetables Trading and LCJ General Merchandise in writing of its post-disqualification;

WHEREAS, on the same day, RCU Fruits and Vegetables Trading filed a Motion for Reconsideration, however, it was decided by the BAC not to grant their Motion for Reconsideration by issuing a Letter of Denial on November 27, 2024, in response to their motion;

WHEREAS, the decision was discussed with the aforementioned bidders and they acknowledged not to grant their Motion for Reconsideration;


