**Addendum to Reso 2025-016 Re-Awarding the Contract for the Procurement of Item nos.1, 6, 7, 10 and 12 and Declaring Failure of Item nos. 2-5, 8, 9, 11 and 13**

WHEREAS, under BAC Resolution No. 2025-1016 dated 16 January 2025, the Bids and Awards Committee (BAC) awarded the items to the following suppliers:

BIDDER'S NAME	AMOUNT
1. BAN BEE COMMERCIAL CO. INC.;	Php 59,920.00
2. LCJ GENERAL MERCHANDISE;	Php 18,540.00
3. RYRAH MERCHANDISING;	Php 18,000.00

WHEREAS, under BAC Resolution No. 2024-1097 dated 23 December 2024, the BAC recommended the use of **Shopping** as the Mode of Procurement, under Rule IV of Republic Act No. 9184 provided that, as a general rule, all procurement shall be done through competitive bidding except as provided for in Rule XVI of RA 9184, allowing the use of alternative methods of procurement:

*Procurement of ordinary or regular supplies and equipment not available in the Procurement Service involving an amount not exceeding One Million Pesos (P1,000,000.00): Provided, however, That the Procurement does not result in Splitting of Contracts: Provided, further, that at least three (3) price quotations from bona fide suppliers shall be obtained.*

WHEREAS, in response to the posting and request for quotation, **FOUR (4)** suppliers submitted their bid on 3 January 2025, as follows:

1. BAN BEE COMMERCIAL CO. INC.;	3. RPD CHEM ENTERPRISE;
2. LCJ GENERAL MERCHANDISE;	4. RYRAH MERCHANDISING;

WHEREAS, under Section 52.1 (b) of Republic Act 9184, the BAC shall send the RFQs to at least three (3) suppliers of known qualifications, and at least three (3) price quotations must be obtained. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate;

WHEREAS, For item nos. 2, 3, 8 and 9, only **TWO (2)** suppliers submitted bids, resulting in the failure of those items;

**NOW THEREFORE**, the herein members of the BAC **HEREBY RESOLVE** to Recommend the Following;

- To award Item Number 6, 7 and 10 to **BAN BEE COMMERCIAL CO. INC.** which was determined as the Lowest Calculated and Responsive Bid (LCRB) with a Total Contract amount of ~~₱ 37,000.00, Thirty Seven Thousand Pesos Only;~~ <sup>₱42,060.00, forty two thousand six hundred sixty Pesos Only;</sup>
- To award Item Number 1 to **RYRAH MERCHANDISING** which was determined as the Lowest Calculated and Responsive Bid (LCRB) with a Total Contract amount of **₱18,000.00, Eighteen Thousand Pesos Only;**
- To award Item Number 12 to **LCJ GENERAL MERCHANDISE** which was determined as the Lowest Calculated and Responsive Bid (LCRB) with a Total Contract amount of **₱9,720.00, Nine Thousand Seven Hundred Twenty Pesos Only;**
- Item nos. 4, 5 and 13 were declared as **FAILED** due to the quoted price was above ABC;
- Item nos 2, 3, 8, 9, 11 and 13 were declared as **FAILED** due to only **TWO (2)** Suppliers submitted bids;
