## B. Clarifications:

Section 9 of Republic Act (RA) 11917

Administrative Fee of PSAs. — The minimum administrative fee that may be charged by PSAs to its clients shall not be less than twenty percent (20%) of the total contract cost, subject to adjustment by the Department of Labor and Employment: *Provided*, that additional fees shall be charged for the *acquisition and maintenance of extraneous tools and equipment used for security operation by the agency* or required by the clients and for the *continuous deployment of PSPs in hazardous conditions*.
