APPROVING THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF ITEM NOS. 1-20

- 1. To Award the Contract of item nos. 3, and 5-9 to FGG DOOR TO DOOR RETAILING, which was determined as the Lowest Calculated and Responsive Bid (LCRB) with a Total Contract amount of ₱37,620.00, Thirty-Seven Thousand Six Hundred Twenty Pesos Only;
- 2. To Award the Contract of item nos. 12, and 17 to MARDAI ENTERPRISES, which was determined as the Lowest Calculated and Responsive Bid (LCRB) with a Total Contract amount of ₱1,260.00, One Thousand Two Hundred Sixty Pesos Only;
