RECOMMENDING THE USE OF DIRECT CONTRACTING AS ALTERNATIVE METHOD OF PROCUREMENT AND APPROVING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF MAGNESIUM GEN. 2 & CREATINE KINASE

WHEREAS, on October 03, 2025, the BAC received a request from the Laboratory Unit for the PROCUREMENT OF MAGNESIUM GEN. 2 & CREATINE KINASE as per Purchase Request No. 2025-09-0306, dated September 19, 2025;

WHEREAS, the said items will be procured through Internally Generated Fund (Income) as per Clinical Laboratory's approved Project Procurement Management Plan (PPMP) 2025 and Work and Financial Plan (WFP) FY 2025;

WHEREAS, STA. ANA ENTERPRISES is the exclusive distributor of Reagents and Consumables for Cobas Integra 400 plus, provided in the Certificate of Exclusive Distributorship (CED) for the above-mentioned items;

WHEREAS, Rule IV of Republic Act No. 9184 provided that, as a general rule, all procurement shall be done through competitive bidding except as provided for in Rule XVI of RA 9184, allowing the use of alternative methods of procurement:

Procurement of goods of proprietary nature which can be obtained only from the proprietary source, i.e., when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;

When the procurement of critical plant components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract; or

Those sold by an exclusive dealer or manufacturer that does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP.

NOW THEREFORE, in consideration of the above premises, the herein members of the **BAC RESOLVE** to recommend the following:

1. Recommend the use of Direct Contracting for the provision of the said item / services.
2. Secure approval of the Head of the Procuring Entity for the conduct of Direct Contracting as an alternative mode of procurement.
3. To **Award the Contract for the PROCUREMENT OF MAGNESIUM GEN. 2 & CREATINE KINASE to STA. ANA ENTERPRISES** which was determined as the EXCLUSIVE DISTRIBUTOR / DEALER.
